The undersigned hereby makes, constitutes and appoints each of Lesha Shinn, Chantal Veillon and John Siemann, or either of them acting singly, and with full power of substitution, re-substitution and delegation, the undersigned's true and lawful attorney-in-fact (each of such persons and their substitutes and delegees being referred to herein as the "Attorney-in-Fact"), with full power to act for the undersigned and in the undersigned's name, place and stead, in the undersigned's capacity as an officer, director or stockholder of Integra LifeSciences Holdings Corporation (the "Company"), to:

1.
